Meb asked several clarifications on the TOC:

- Does section 3.1 Overview of LHC Data Challenges only cover EGEE Production Service (LCG-2) or also other Grids? Frank answered that it would also cover all other Grids used.
- We understand that it this context, "Migration" means "migrating application to the Grid", not migration from one Grid to another.
- Section 3.5 Summary of Work by non-LHC experiments on LCG-2 refers to "other HEP application than LHC"

With these clarifications made, the TOC was accepted as is.

Meb pointed-out that there was no reviewer from non-HEP communities. We agreed to ask Vincent to nominate an extra reviewer from BioMeb and/or Generic application community.

The TOC was accepted with the above mentioned change.

DJRA3.2 Site access control architecture (TOC)

Frank asked how this work was related to David Kelsey's work. Ake answered that they are not doing the same thing. Both are in MWSG and JSPG and are in regular contact. Both are in JRA3 and are in regular contact.

Bob asked what was the plan for LCG-2 and gLite. We agreed that this work needs to be well coordinated with David K. and that it is reflected in gLite.

MJRA3.5 Secure Credential Storage procedures (TOC sent 02/11/04 and accepted.)

This work will not be part of gLite RC1. Kostas explained that this work will start with a throwaway prototype. After discussions Frédéric, Bob and Kostas, we agreed that since the

Kostas agreed that his new team will follow this way of working for the real implementation.
