Gabriel read the status given by the Moderator for all PM9 deliverables and milestones.

Frank asked when the TF would conclude on gLite. Bob said that the TF was agreeing on the feature list of gLite for RC1, for PM10 MJRA1.5. Then, 2 months later, the s/w will be released to SA1. Bob also said that the TF agreed that no resources would be allocated to support experiment specific deployment.

We agreed that due to the TF still working on this content of RC1, the presentation of MJRA1.4 would not be given during the face-to-face meeting the following week.

The deadline for the deliverables for the EU is the 19<sup>th</sup> January.
